#### **HEALING PEOPLE**

Interaction between horse and human is integral to the success of our mission. Our clients come to us with pain beyond what some humans can fully understand or appreciate. But when they are paired with a horse who has also experienced tragic circumstances, our clients become the recipients of unexplained trust and acceptance that is a catalyst for healing from addiction, abuse, exhaustion, depletion, and other personal traumas.

#### **HEALING HORSES**

Our horses come to us from brutal circumstances. At the time of their rescue, most are deemed worthless and untouchable. But upon admittance to our ranch, COLT works to restore each animal's well-being—to develop heartfelt relationships until they feel confident, connected and trusting. Today, we have 15 horses who facilitate healing connections with people from all walks of life.





## **GIFT OPPORTUNITIES**

#### \$300

#### **INDIVIDUAL SESSIONS**



Through a series of intimate one-on-one sessions, we facilitate horse-human connections that are designed to improve the health and well-being of both species. A gift of \$300 can provide a one-hour horse and client session led by our co-founders.

## \$500

#### **VETERINARY CARE**

Our horses live in an environment where their safety and security are the first priority. We provide a place for them to heal physically and emotionally. A gift of \$500 can provide an annual dental visit.

## \$1,000

#### THERAPEUTIC TRAINING

Our veteran trainers believe that by allowing horses to be who they were meant to be, they eventually develop into conduits of therapy for people who are struggling and as such, become an asset to the community. A gift of \$1,000 can provide one month of intensive training for one horse.

## \$2,300

## **REHABILITATION AND TIME TO HEAL**

Our horses come to us with traumatic histories and unique needs. Rehabilitation and retraining these special horses may take months, and often years. A gift of \$2,300 can provide one year of food and basic care for one horse.

## \$3,000

#### **GROUP WORKSHOPS**

Our goal is to help clients increase self esteem, strengthen boundary setting, and learn relationship building. A gift of \$3,000 can provide a daylong workshop for 6 clients, each of whom is paired with a horse and guided through a process where they learn to interact with the horse.



## \$10,000 PAY IT FORWARD



As our organization grows, so do opportunities to train the next generation of young professionals with similar passions to learn how to facilitate the mutual healing of horses and humans. Co-founders Joost Lammers and Erica Hess are veteran trainers with decades of experience in horsemanship, dressage, liberty training, leadership and equine assisted coaching.

A gift of \$10,000 can help provide paid internships and work studies for therapists, social workers and horsemen to gain experience and enhance their expertise, while also contributing to COLT's general operations and overall capacity to serve the many people who come to us from across the state of New Mexico.

# IN HONOR OF OUR GRANDFATHER

Fifteen years ago, we received the gift of a large and handsome rescue horse, Yogi, who'd been described as a "useless, good-for-nothing and unrideable" animal. Yogi was given to us out of the belief that if anyone could retrain him, it would be one of us.

We succeeded briefly, but it soon became clear that Yogi could barely tolerate a rider because of some profound trauma. We began the process of retraining Yogi at liberty—using no ropes or tack to restrain him, so he was free to stay or leave. In the time that followed, we developed with Yogi the kind of relationship that few horses and humans ever experience.

As we worked to rehabilitate Yogi, it became clear that with his trauma also

came an understanding—a recognition, if you will—of heartache in humans. This kind of horse-human connection, we observed, could help heal both species. Our relationship with Yogi grew into a bond that ultimately sparked a vision for the kind of work we accomplish today.

Last year, Yogi won the John Henry Award for the most outstanding service animal in New Mexico. Sadly, Yogi passed away just recently at age 35—nearly 100 in human years. He was our gentle giant and the spiritual master of our herd. And he will always be the foundation of our program for horse-human healing, continuing to guide, inspire and heal us.
